Selection of the glove material on consideration of the penetration times, rates of diffusion and the degradation

Material of gloves

Nitrile gloves with a material thickness of > 0.1 mm (penetration time < 30s).

Protective nitrile rubber gloves according to EN 374 are recommended for prolonged contact.

Material thickness > 0.4 mm

Breakthrough time > 30 minutes

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

#### · Penetration time of glove material

The exact break trough time has to be found out by the manufacturer of the protective gloves and has to be observed.
